- This Application Form is meant to enable a person to comply with the client identification programme laid down by the Prevention of Money Laundering Act, 2002 (PMLA) hereinafter referred to as Know Your Customer (KYC) requirements. It is for use by **INDIVIDUALS** only. A separate form is provided for non-individual entities such as Hindu Undivided Family, Corporates, 1. Trusts, Societies, etc.
- This form is not an Investment Application Form, and is only meant for providing information and documents required for KYC compliance. Applicant must be KYC compliant while investing 2. with any SEBI registered Mutual Fund which is a <u>Participating Mutual Fund</u> for the purpose of the KYC compliance. Participating Mutual Fund means any SEBI registered Mutual Fund which has subscribed to the services of CDSL Ventures Limited (CVL) for compliance of the KYC procedure. - Applications for Financial Transactions and Non Financial Transactions, other than Change of Address / Name / Status / Signature must not be submitted at PoS along with KYC application forms, but submitted only at the designated Investor Service Centres / Official Points of Acceptance of Participating Mutual Funds.
